

Program is in legal review.



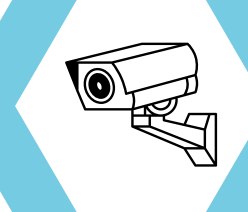
